Chair Franklin called the meeting to order at 9:03 A. M. The Pledge of Allegiance and Roll Call followed.

Safety Briefing – 3

Rich Dalton briefed attendees on safety procedures and assigned specific tasks to qualified staff members in case of an emergency.

Approval of the Agenda - 4

Mr. Walkinshaw moved, with a second by Ms. Bohmke, to approve the agenda as presented. There was no discussion on the motion. The vote in favor was cast by Members Alcorn, Bagley, Bohmke, Franklin, Garvey, Lawson, McLaughlin, Smith, and Walkinshaw.

Approval of the Minutes of the February 18, 2022 VRE Operations Board Meeting – 5

Ms. Bohmke moved, with a second by Ms. Garvey, to approve the Minutes from the February 18, 2022 Board meeting. The vote in favor was cast by Members Alcorn, Bagley, Bohmke, Franklin, Garvey, Lawson, McLaughlin, Smith, and Walkinshaw.

<u>Chair's Comments – 6</u>

Chair Franklin pointed out that the April VRE Operations Board meeting is scheduled for Good Friday and the start of Passover and asked if there were any concerns with moving the April Board meeting to April 22, 2022. Ms. Bohmke moved, with a second by Ms. Garvey, to move the April VRE Operations Board meeting from April 15th to April 22nd to avoid any potential conflicts. The vote in favor was cast by Members Alcorn, Bagley, Banks, Bohmke, Franklin, Garvey, Lawson, McLaughlin, Smith, and Walkinshaw.

Chair Franklin informed Members that the Executive Committee had discussions about appointing a Secretary for the Operations Board. Ms. Lawson moved, with a second by Mr. Alcorn, to elect Ms. Bagley as Secretary of the VRE Operations Board for 2022. The vote in favor was cast by Members Alcorn, Bagley, Banks, Bohmke, Franklin, Garvey, Lawson, McLaughlin, Smith, and Walkinshaw.

The Members discussed exploring changes to the Bylaws to ensure representation of the southern jurisdictions on the Executive Committee. Chair Franklin appointed a Bylaws Committee comprised of Members Bohmke, Garvey, Kelly, and Walkinshaw, to review and address equity in rotation of Board Officers. Chair Franklin invited all other Members to let her know if they would like to participate on the Committee.

Secretary Miller stated he was happy for the opportunity to speak with the Board about VRE and rail in Virginia, and introduced himself, Deputy Secretary Jen Deci, and Assistant Secretary Michael Sargent. Secretary Miller spent several minutes discussing the importance of rail and public transportation, his appreciation for VRE, and answered questions from Board Members.

Ridership Recovery Efforts – 10A

VRE staff members gave a presentation to the Board outlining various marketing, promotional, and outreach strategies to increase ridership on VRE trains.

<u>Spending Authority Report – 10B</u>

In January, the following purchases greater than \$50,000 but less than \$100,000 were made:

- On February 7, 2022, VRE issued a Task Order in the amount of \$76,024 to Keolis Rail Services Virginia under the Maintenance Services for Commuter Rail Operations contract to address the failure of the turbocharger on locomotive V65 and to provide support for the rear gear train replacement.
- On February 11, 2022, VRE issued a Task Order in the amount of \$161,400 to HDR Engineering under the General Engineering Consulting Services contract for conceptual design phase services for the Crossroads Yard Expansion Project.
- On February 24, 2022, VRE issued a Purchase Order in an amount not to exceed \$52,080 to Powersolv,
 Inc. to provide cybersecurity consulting support in order to conduct risk assessments, gap analyses,
 and to review and revise VRE's cybersecurity policies.
