## Recommend Authorization to Amend a Site Lease Agreement for Real Property in Fredericksburg – 10A

Mr. Kelly moved, with a second by Mr. Walkinshaw, to recommend the Commissions authorize the Chief Executive Officer to amend a site lease agreement with Qwest Corporation of Delaware for property owned by the Commissions adjacent to the railroad right-of-way and the VRE Fredericksburg office, extending the term of the Lease by ten years. The vote in favor was cast by Members Alcorn, Bagley, Bailey, Bohmke, Franklin, Garvey, Hayes, Kelly, Lawson, McLaughlin, Mensing, Storck, and Walkinshaw.

#### Authorization to Extend Fare Free Travel and Offer Reduced Fares between Zones 1, 2 and 3 – 10B

Mr. Storck moved, with a second by Ms. Garvey, to authorize the Chief Executive Officer to continue to offer fare free travel between zones 1, 2 and 3 until Metrorail service south of Reagan National Airport reopens in November 2022 and to offer promotional fares for zones 1, 2 and 3 throughout the duration of the Yellow Line bridge shutdown. ## Approval of the Preferred Alternative for L'Enfant Track and Station Improvements – 10C

#### FY 2024 Budget Update -11A

VRE Chief Financial Officer, Mark Schofield, briefed the Members on the ongoing effort to develop a balanced FY 2024 Budget. He encouraged Members to attend the Finance Committee meeting following November's Operations Board meeting.

## <u>Fare Free September Ridership and Survey Results – 11B</u>

VRE saw a 21% increase in monthly ridership exclusive of boardings at Alexandria and Crystal City. A survey of passengers was taken throughout Fare Free September in which seventy percent identified themselves as returning riders and thirty percent identified themselves as new riders. Approximately 80% of survey respondents stated they planned to continue to ride VRE after the fare free period ends.

## <u>Draft 2023 Legislative Agenda – 11C</u>

VRE staff reviewed recommendations to formulate priorities to communicate and advocate for/with the Governor's administration and the General Assembly. Additionally, the Legislative Agenda will include federal legislative and regulatory issues that are relevant to transit and commuter rail in the U.S., and to VRE specifically.

Comments: Dear Members of the Board, I am writing to

> express my support for the board voting in favor of proposal 10B to extend the free fare period for the VRE within Zones 1, 2, and 3 and to thereafter utilize discounted fares during the Yellow Line shutdown. Speaking to the latter part of the proposal, a fare reduction would bring the VRE pricing more in line with Metrorail and increase VRE's appeal. It can be hard to justify paying a minimum \$7.80 to ride within these zones despite the more direct and faster routing as compared to Metrorail because of the current high cost of VRE. However, at the proposed lower price point, the VRE uniquely allows a one-seat ride as compared to a multi-transfer ride between VA and popular destinations such as Union Station at nearly the same cost. My hope is that, if the new fare is sufficiently advertised, ridership within the 3 zones will increase enough to make the proposal revenue

neutral over time. Thank you for your

VRE Operations Board,


Please consider the following public comment:

I recommend the VRE request funding from the I-395/95 Commuter Choice FY 2024-2025 Program for **two years of operational costs** associated with Acquisition Phase train slots on the both lines as detailed in the Transforming Rail in Virginia Service Plan. The new service start date should be coordinated with a major VRE project milestone such as the opening of Potomac Shores Station or Manassas Park VRE parking garage.

In addition, I continue to be concerned about the long term viability of the VRE service based on the teleworking post pandemic paradigm and competition from the future I-66 and I-95 express lane corridors.

Also, the region is experiencing a significant housing shortage.

To mitigate both of these issues I strongly recommend that the best solution to expanding ridership is to develop an additional 10,000 mixed-income dwelling units within 1/8 mile of the VRE platform across the stations south of Alexandria. This requires a collaboration between the PRTC/VRE and the jurisdictions representing VRE. A blueprint should be developed ASAP and be a major element of the 2050 VRE plan.
