A. Authorization to provide a letter of support for Amtrak's Application for FY22 Federal-State Partnership for Intercity Passenger Rail Program Funding for the Crystal City High Level Platform Project

Amtrak has requested VRE provide a letter of support for its application to the Federal-State Partnership for Intercity Passenger Rail Program. If awarded, the funds will be used for the Crystal City High Level Platform Project.

AUTHORIZATION TO ISSUE AN MEC VII TASK ORDER FOR NATIONAL TRANSIT DATABASE AND ASSET REPORTING PHASE IX

Recommendation:

The VRE Operations Board is asked to authorize the CEO to issue a mechanical engineering consulting services (MEC VII) task order to STV Incorporated for National Transit Database and Asset Management Reporting Phase IX in the amount of \$469,315, plus a 10 percent contingency of \$46,932, for a total not to exceed \$516,247.

Summary:

Under the terms of this contract, STV will maintain and enhance three distinct data support systems:

- VRE Transit Asset Management System An internet-based assessment management tool for VRE that features an executive dashboard and modules that include inventory data and the ability to conduct condition assessments for facility, equipment, rolling stock, and infrastructure assets.
- ArcGIS Online Software Applications used in collecting inventory and condition data in the field.
- Capital Project Ranking Tool In response to Federal Transit Administration comments provided in VRE's last triennial review, STV developed a capital project ranking tool to supplement the decision support process documented in VRE's 2022 Transit Asset Management Plan. The tool offers a quantitative approach to evaluating potential projects using a numeric ranking methodology with scores that are derived by applying VRE's decision-making questions and prioritization hierarchy.

AUTHORIZATION TO EXECUTE A CONTRACT FOR PROGRAM MANAGEMENT CONSULTING SERVICES

Recommendation:

The VRE Operations Board is asked to authorize the CEO to execute a contract with Hill International, Inc. of Philadelphia, PA for program management consulting (PMC) services for a base year and three option years in an amount not to exceed \$1.5 million per year for a total not to exceed \$6 million for the four-year term of the contract. The option years may be exercised at the CEO's discretion.

Summary:

Given the growth in the number and complexity of projects projected in VRE's Capital Improvement Program for the next six years, VRE needs to expand its program management capacity for successful project delivery. This includes additional project management and procurement resources, as well as personnel with special expertise to augment VRE's present staff, in order to deliver a high volume of capital projects on time.

On March 18, 2016, the VRE Operations Board authorized the CEO to issue a request for proposals for program management consulting services. The PMC contract will employ task order agreements. VRE Operations Board approval is required prior to award of each task order in excess of the CEO's delegated spending authority.





AUTHORIZATION TO EXECUTE A CONTRACT FOR FORKLIFT TRUCKS

Recommendation:

The VRE Operations Board is asked to authorize the CEO to execute a contract with Wiese USA, an authorized dealer of Mitsubishi Caterpillar Forklift America Inc., of Baltimore, Maryland for forklift trucks in the amount of \$383,384, plus a 10 percent contingency of \$38,338, for a total amount not to exceed \$421,722.

Summary:

VRE relies on forklifts to move materials throughout the maintenance and storage facilities. With time and use, the five forklift trucks purchased between 1998 and 2007 have worn out, requiring excessive repairs and downtime. The contract with Wiese USA will require delivery of the five new forklifts within 52 weeks unless otherwise extended.

AUTHORIZATION TO EXECUTE A SOLE SOURCE CONTRACT FOR THE PURCHASE OF LOCOMOTIVE RADIATORS

Recommendation:

The VRE Operations Board is asked to authorize the CEO to execute a sole source contract with Wabtec Global Services of Pittsburgh, PA for locomotive radiators in the amount of \$1,139,468, plus a 10 percent contingency of \$113,947, for a total amount not to exceed \$1,253,415.

Summary:

Forty-four new locomotive radiators are needed to replace existing radiators that have reached the end of their useful life. Wabtec Global Services is the only known supplier of service-proven radiators designed to optimize cooling water flow for VRE's MP36PH-3C locomotives. The radiators will be installed by VRE's maintenance contractor.

AUTHORIZATION TO EXTEND THE LEASE AGREEMENT FOR PARKING AT THE RIPPON VRE STATION

Recommendation:

The VRE Operations Board is asked to authorize the CEO to extend a lease agreement with RCKF Riverside PLP LLC, formerly KP Big Crest Lane, LLC, for parking at the Rippon station in the amount of \$193,176 for one year.

Summary:

The lease agreement, for 320 parking spaces, will serve riders boarding at the Rippon station. An agreement for these parking spaces has been in place since 2004, and the current extension of the agreement runs through the end of February 2023. A proffer statement / development plan executed between Prince William County and KP Big Crest Lane, LLC, now RCKF Riverside PLP LLC, in 2011 stipulates an annual 2 percent increase in the lease amount. Factoring in this increase, the annual cost is \$193,176 for 2023-2024.

ENDORSEMENT OF THE PREFERRED CONCEPT FOR THE BROAD RUN EXPANSION PROJECT NEAR-TERM IMPROVEMENTS

Recommendation:

The VRE Operations Board is asked to endorse a preferred concept for the Broad Run Expansion Project near-term improvements. The new concept employs a site located south of the Broad Run station and Norfolk Southern Railway (NS) tracks as the preferred location for the expanded yard, station and parking.

Summary:

VRE has continued to refine design of the near-term improvements for the Broad Run Expansion Project. The purpose of this item is to endorse a preferred location and concept for expanded station parking, yard improvements and station relocation.

The proposed improvements include:

- Expansion of the existing Broad Run Maintenance and Storage Facility to accommodate additional railcars
- Additional parking spaces at the Broad Run station
- A third mainline track between Manassas Junction and Broad Run station within the existing NS right-of-way, subject to NS review and approval
- Adjustment and minor relocation of the Broad Run platform to accommodate the above changes

Background

- In March 2020, PRTC engaged Baker Tilly US, LLC (Baker Tilly) to conduct and analyze a Classification and Compensation study on all PRTC OmniRide and VRE positions
- In July 2021, PRTC adopted a Pay Plan recommended by Baker Tilly for *OmniRide employees only*
- VRE was authorized to proceed with continued examination of VRE positions to ensure consideration was given to unique roles & duties for VRE rail-specific positions
- VRE engaged with the same consultant for this purpose and a VRE proposed Pay Plan was developed that reflects the desire for pay to be internally equitable and market competitive

Pay Plan

- ✓ A framework for providing fair and transparent compensation for all employees
- ✓ Consists of grades with minimum and maximum pay rates for each
- ✓ Positions are then assigned to grades based on internal equity and market pricing

- 40 pay grades
- Minimum and maximum pay rates for each grade

Methodology

- Position reviews and market data established in the first study were used in the supplemental study for positions other than the ones chosen for continued examination:
 - Director of Mechanical Operations
 - Director of Rail Operations
 - Director of Planning & Environmental Policy
 - Manager of Facilities Management
 - Planning Program Manager
 - Project Manager Design & Construction
 - Warehouse & Inventory Control Specialist
 - Director of Government & Community Affairs
 - Budget Manager
 - Included because job description & title were updated since first study

The Process:

- ✓ Job description updates
- ✓ Position reviews (internal equity)
- ✓ Market assessment (external equity)
- √ Pay Plan development
- ✓ Position assignments within the proposed Pay Plan

• All results were merged and used for developing a proposed VRE Pay Plan



An Impactful Study

- 7 of the 9 of the positions re-evaluated were scored higher in Baker Tilly's job evaluation process than in the original study
- 27 of the 41 position titles examined (internally and externally) were assigned to pay grades that varied from the original study (some higher, some lower)
 - This is indicative of the fact that this supplemental review was necessary to identify a competitive and equitable Pay Plan for VRE
- VRE will maintain the classification and compensation system by utilizing Baker Tilly's Systematic Analysis Factor Evaluation (SAFE) methodology



SPENDING AUTHORITY REPORT

On September 18, 2020, the VRE Operations Board approved increasing the CEO's delegated spending authority from \$100,000 to \$200,000. It was resolved as part of that increased delegation that any purchase or contract award in the range of \$50,000 to \$200,000 would be communicated to the Board as an information item.

• On January 5, 2023, VRE issued a task order in an amount not to exceed \$90,710 to STV Incorporated under the general planning consulting services contract for general planning support on an as-needed basis. The purpose of this task order is to obtain consultant support as necessary over a term of 24 months for multiple VRE projects, including assistance with the completion of National Transit Database annual reporting and analyses of VRE and regional data in response to requests for information. The first assignment anticipated under this task order is to assist in developing a grant application to the NVTC Commuter Choice Program.
